Cohesion Objectives



- PO1 A Smarter Europe, through innovation, digitisation, economic transformation and support to small and medium-sized businesses
- PO2 A Greener, carbon free Europe, implementing the Paris Agreement and investing in energy transition, renewables and the fight against climate change
- PO3 A more Connected Europe, with strategic transport and digital networks
- PO4 A more Social Europe, delivering on the European Pillar of Social Rights and supporting quality employment, education, skills, social inclusion and equal access to healthcare
- PO5 A Europe closer to citizens, by supporting locally-led development strategies and sustainable urban development across the EU.

Conditions: Thematic concentration



ERDF

- 60% of investment in PO1
- Together, 85% of investment in PO1 and PO2
- 6% dedicated to sustainable urban development

ESF+

- 25% of spending on promoting social inclusion and tackling poverty
- For countries with high NEETS, 10 15%
- Up to 5% devoted to Innovative Actions

Enabling conditions: e.g. Smart Specialisation

The situation in Italy



- Italian authorities still in discussion with the Commission
- "Unifying themes" for Italian Programmes:
 - quality work
 - natural resources for future generations
 - standardisation and quality in services for citizens
 - culture as a vehicle for economic and social cohesion
- Development of National and Regional Programmes
- Funds remaining from 2014 20 programming period

- Identify opportunities in Programmes, as currently drafted (note the four themes)

- Consider how far it is still possible to influence Programmes
- Remember the main priorities of Cohesion Funds and develop ideas about responding to them
- Start to develop a comprehensive Active Development approach to integrate sport into economic & social development

- Identify potential project partners and start to formulate proposals
- Identify potential sources of matching funding required
